Note 1: Shares under Category "Public" include 68 33 410 fully paid-up equity shares held in the Unclaimed Suspense Account and 3 45 93 353 fully paid-up equity shares held by Investor Education and Protection Fund (IEPF) Authority on which voting rights are frozen. Shares under Category "Public" also include 8 59 742 partly paid-up equity shares on which First Call has not been paid and accordingly, voting rights in respect of these shares can only be exercised upon payment of First Call.

Note 2: Voting Rights on shares are in proportion to the amount paid-up on the face value of such shares.

Note 3: As the shareholding pattern upload utility on the stock exchanges' websites does not recognise voting rights in fractions, the same have been rounded-off to the nearest full figure.

Note 4: The aggregate voting rights (before rounding-off) of: (i) Promoter and Promoter Group are 321 05 99 974.50, (ii) Public shareholders are 314 36 61 197.00 and (iii) Non-Promoter Non-Public (Shares underlying GDRs) are 19 62 80 460.00.

Note 5: There is no change in the shareholding of Promoter & Promoter Group. The percentage of Promoter & Promoter Group as shown in (VIII) (A) has increased (as compared to the percentage shown in the shareholding pattern for the quarter ended June 30, 2021) because the shares underlying DRs (which have gone up as on September 30, 2021 vis-a-vis as on June 30, 2021) are not considered for the purpose of calculating the shareholding percentage under the SCRR, 1957.

Note 6: In terms of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, BSE and NSE have approved the reclassification of Reliance Industrial Infrastructure Limited ("RIIL") (holding 0.005% of voting rights) from the category of "Promoter Group" of the Company to "Public". Consequently, RIIL stands re-classified from category of "Promoter Group" of the Company to "Public" with effect from October 8, 2021.
