The Appointed Date for the Scheme was close of business hours of December 31, 2022 and the Effective Date is August 9, 2023. The demerged undertaking of RPPMSL includes assets, liabilities and reserves of Reliance Infratel Limited, which was acquired by and merged into RPPMSL on the appointed date of December 22, 2022. Accordingly, the closing balance is arrived at after giving effect to the Scheme.

8 Hon'ble National Company Law Tribunal, Mumbai Bench, vide its order dated June 28, 2023 sanctioned the Scheme of Arrangement providing for demerger and transfer of the Financial Services Business of the Company ("Demerged Undertaking") to Jio Financial Services Limited (formerly known as Reliance Strategic Investments Limited). The Appointed Date for the Scheme was close of business hours of March 31, 2023 and Effective Date of the Scheme is July 1, 2023.

9 In terms of the scheme of arrangement sanctioned by Hon'ble National Company Law Tribunal, allotment was made by Viacom18 Media Private Limited of 11,89,03,290 class A compulsorily convertible preference shares (CCPSs) to the Company. Further, 2,00,88,090 CCPSs and 11,95,36,257 CCPSs were allotted to Reliance Projects & Property Management Services Limited and Reliance Strategic Business Ventures Limited, respectively.

10 Hon'ble National Company Law Tribunal, Ahmedabad Bench and Mumbai Bench have sanctioned composite scheme of amalgamation of Reliance Infratel Limited ("RITL") and Reliance SMSL Limited ("RSM SL") with Reliance Projects & Property Management Services Limited ("RPPMSL"). The Appointed Date for the scheme of amalgamation with RPPMSL was close of business hours of December 22, 2022 and March 31, 2023 for RITL and RSM SL, respectively. Accordingly, the closing balance is arrived at after giving effect to the scheme.
