The shareholding percentage of Promoter & Promoter Group as shown in (VIII) (A) has increased (as compared to the shareholding percentage as on September 30, 2023) because 39 68 852 equity shares have been deposited with ICICI Bank Limited, domestic custodian for The Bank of New York Mellon (GDR Depository) for issue of DRs and the shares underlying DRs have gone up as on December 31, 2023 vis-a-vis as on September 30, 2023.
