Note 1 Voting Rights under Category "Public" include 55 24 793 fully paid-up equity shares held in the Unclaimed Suspense Account, 92 741 fully paid-up equity shares held in Suspense Escrow Demat Account and 3 60 76 288 fully paid-up equity shares held by Investor Education and Protection Fund (IEPF) Authority on which voting rights are frozen. Shares under Category "Public" also include (i) 2 53 773 partly paid-up equity shares on which First Call as well as Second and Final Call has not been paid and accordingly, voting rights in respect of these shares can only be exercised upon payment of First Call and Second and Final Call; (ii) 1 63 645 partly paid-up equity shares on which Second and Final Call has not been paid and accordingly, voting rights in respect of these shares can only be exercised upon payment of Second and Final Call. The fully paid up equity shares under Category "Public" include 763 equity shares for which corporate action was not completed as on March 31, 2024 including 444 equity shares for which call money has been received by the Company during the quarter ended March 31, 2024.

Note 2 Voting Rights on shares are in proportion to the amount paid-up on the face value of such shares.

Note 3 As the shareholding pattern upload utility on the stock exchanges' websites does not recognise voting rights in fractions, the same have been rounded-off to the nearest full figure.

Note 4 The aggregate voting rights (before rounding-off) of: (i) Promoter and Promoter Group are 332 27 48 048.00, (ii) Public shareholders are 328 12 71 597.75 and (iii) Non-Promoter Non-Public (Shares underlying GDRs) are 16 18 17 216.00

Note 5 There is no change in the total shareholding of Promoter & Promoter Group. The shareholding percentage of Promoter & Promoter Group as shown in (VIII) (A) has increased (as compared to the shareholding percentage as on December 31, 2023) because 21 14 746 equity shares have been deposited with ICICI Bank Limited, domestic custodian for The Bank of New York Mellon (GDR Depository) for issue of DRs and the shares underlying DRs have gone up as on March 31, 2024 vis-a-vis as on December 31, 2023.

Note 6 As per information furnished by the Promoter and Promoter Group, there are 52 members forming part of Promoter and Promoter Group of the Company, of which 5 promoter group entities do not hold any shares.
