

# As rain pounds state, crop loss up from 60,000 ha to 1.5L ha in a week

### Kolhapur Dist Worst Hit With Loss Of 31k Ha

Kolhapur/Pune: Crops spread over 1.5 lakh hectares have been damaged in the state following the recent heavy rain fall, with Kolhapur district emerging as worst-affected with expected crop loss of over 31,000 hectares in 592 villages, latest report of the agriculture department showed on Wednesday.  
A week ago, crop damage

was 60,000 hectares, report stated. A senior agriculture department official said, "Most of the affected crops were in crucial growth stages, having been in the ground for 40-45 days post-sowing. Unfortunately, the window for resowing has also closed. We've observed severe soil erosion in low-lying regions adjacent to water bodies. About 500 hectares of arable land has been washed away in the floods. By the time the eroded lands are reclaimed and prepared for cultivation, we'll be well into Sept. This timing effectively rules out resowing of kharif crops for these areas. Affected farmers may shift their focus to rabi crops now."  
Agriculture department in Kolhapur has started crop damage assessment in areas where floodwater has receded. District agriculture officer Ajay Kulkarni said, "Farmers were inundated after heavy rainfall for the last 10-15 days. The work for assessing the crop damage has started on a war footing. Farmers whose fields were inundated should submit a copy of Eight A form, Aadhaar card and photocopies of bank passbook to agriculture assistants."

# HC overturns 2 DMK ministers' acquittal in graft & assets cases

Chennai: Madras high court on Wednesday set aside the acquittal of DMK ministers KKSRR Ramachandran and Thangam Thennarasu in two separate corruption and disproportionate assets cases, and asked a Virudhunagar special court to frame charges against them.  
Ordering restoration of the cases, Justice N Anand Venkatesh directed revenue minister Ramachandran and finance minister Thennarasu to appear before the trial court on Sept 9 and Sept 11, respectively, to execute bonds for their appearance,

as and when summoned. deal with this situation with an iron hand, lest this becomes an inspiration for politicians in other states, who are facing criminal prosecutions. Justice Venkatesh said. The HC observed the special court has committed a manifest error by exceeding its jurisdiction and discharging the accused by relying upon tested materials gathered by the subsequent investigating officer in the "final closure report" and treating them as genuine, he said.  
The judgments are a model of how a judgment should not be written, the court said. Thennarasu was acquitted by a special court on Dec 12, 2022, while Ramachandran was acquitted on July 20, 2023.

# Fire in Nagpur bldg kills teen, parents critical

Nagpur: A second blaze tore through choked alleys of Itwari within a week, killing a 17-year-old girl, Anushka Bakhade. She had locked herself in toilet to escape flames and suffocated to death on Wednesday. The fire erupted in a two-storey commercial-cum-residential building at 4.30am.  
The teen's parents, Pravin and Renuka Bakhade, are battling for life in hospital after they too inhaled smoke. Her brother Sarthak (15) had a lucky escape as he ran to the terrace, leapt on an adjoining one and walked down safely.  
A fire official said the building is illegal. TOI recently highlighted how Itwari had become a "ticking time bomb" due to mushrooming of godowns stashed with inflammable material. - Viraj Deshpande
