Note 1 Voting Rights under Category "Public" include 54 15 577 fully paid-up equity shares held in the Unclaimed Suspense Account, 95 127 fully paid-up equity shares held in Suspense Escrow Demat Account and 3 72 04 229 fully paid-up equity shares held by Investor Education and Protection Fund (IEPF) Authority on which voting rights are frozen. Shares under Category "Public" also include (i) 1 70 171 partly paid-up equity shares on which First Call as well as Second and Final Call has not been paid and accordingly, voting rights in respect of these shares can only be exercised upon payment of First Call and Second and Final Call; (ii) 79 124 partly paid-up equity shares on which Second and Final Call has not been paid and accordingly, voting rights in respect of these shares can only be exercised upon payment of Second and Final Call. The fully paid up equity shares under Category "Public" include 1 03 951 equity shares for which corporate action was not completed as on September 30, 2024 including 1 03 779 equity shares for which call money has been received by the Company during the quarter ended September 30, 2024.

Note 2 Voting Rights on shares are in proportion to the amount paid-up on the face value of such shares.

Note 3 As the shareholding pattern upload utility on the stock exchanges' websites does not recognise voting rights in fractions, the same have been rounded-off to the nearest full figure.

Note 4 The aggregate voting rights (before rounding-off) of: (i) Promoter and Promoter Group are 332 27 48 048.00, (ii) Public shareholders are 329 06 05 617.75 and (iii) Non-Promoter Non-Public (Shares underlying GDRs) are 15 27 08 158.00

Note 5 There is no change in the total shareholding of Promoter & Promoter Group. The shareholding percentage of Promoter & Promoter Group as shown in (VIII) (A) has changed (as compared to the shareholding percentage as on June 30, 2024) because DRs representing 1 13 48 382 equity shares have been converted into equity shares and the shares underlying DRs have gone down as on September 30, 2024 vis-a-vis as on June 30, 2024.

Note 6 As per information furnished by the Promoter and Promoter Group, there are 52 members forming part of Promoter and Promoter Group of the Company, of which 5 promoter group entities do not hold any shares.
